Terms of use Meelunie's Online Customer Portal

Terms of use: Meelunie's Online Customer Portal

Preamble

These terms of use (these Terms) apply to the use of Meelunie 's online customer portal My Meelunie (the Portal), including the use of the information offered on or via the Portal. The use of the Portal is subject to these Terms.

If the user of the Portal (the User) does not accept these Terms – acceptance will take place by means of the acceptance button – the User will not have access to and must refrain from using the Portal.

These Terms must be read in conjunction with any other applicable terms and warnings governing the use of the Portal.

Meelunie may modify the Terms from time to time and such modifications will become effective immediately upon posting the modified Terms on the Portal. Any use of the Portal by the User after any such modified Terms have been posted will be deemed as an acceptance by the User of those modified Terms.

Terminology

In these Terms, the expression Meelunie is a reference to our company, subsidiary and/or affiliate (being part) thereof.

Accessing and using information on this Portal
